#### Aspects to Consider:

Is it clear which partner is doing what tasks? Are the skills of the partners well aligned with the tasks they are planning to perform? Are the partners a good fit for the tasks needed for the placemaking?

Aspects to Consider:

Is the community (people who live, work and/or play within the geographic area) clearly defined by the applicant? Do they include geographic boundaries and demographics? Does the applicant describe why this project will be beneficial to the community members? Does the benefit described by the applicant fit the community needs? Is there evidence that the community influenced the description of benefits to the community?

## Please rate the community involvement that will be implemented by the project.

Aspects to Consider:

Is there evidence of community involvement? Is the way that the community will be involved meaningful? Does the applicant identify special needs within the community and how they will address the needs? Does the applicant address any assets or distinctive components of the community that have been considered in the planning process?
